Bridge Minutes

Tuesday May 12, 2020

1. Call to Order: The meeting was called to order via zoom call at 7:38 pm by L. Kulla

2. Announcements: L. Kulla announces that J. Trainor has resigned as Treasurer and from the club.

3. Approval of Prior Meeting Minutes:

<u>Motion</u>: B. Palafox makes a motion seconded by P. Hirschhorn to accept the April 9, 2020 Bridge minutes as amended. The motion is approved unanimously.

4. Officer/Committee Reports:

a. Commodore's Report:

L. Kulla notifies the Bridge that the newly hired bookkeeper, Maryann Dalimonte is the Town of N. Hempstead Council Woman and that there may be a conflict of interest given her role in both organizations. This will be reviewed by the Ethics Committee of the Town of N. Hempstead and they will inform us of their determination.

The club is likely to remain closed through the end of May. Matt Meyran will be providing water taxi service until launch service is resumed, which is expected around Memorial Day weekend. Members should enter and exit through the Capri Marina Yard. Capt. Vic can prepare the launch for service with two days' notice. Two launch drivers are available once launch service begins.

The club will institute social distancing rules with respect to launch and club use. The Bridge discussed that everyone entering the club will be required to wear a mask and possibly gloves. Hand sanitizer will be made available to people coming through the Club. Social distancing will be maintained on the launch with seating areas designated with guidelines communicated to club members for transporting individuals and groups of family members. Members will be expected to read and sign a COVID Waiver covering themselves, family members and guests. These rules will be communicated to members prior to opening the Club.

Action Item: L. Kulla to communicate social distancing requirements to members prior to opening of the Club.

b. Rear Commodore's Report:

P. Hirschhorn has talked with the company that made the new deck awning about installing it for this year and they will do the installation in mid-May.

c. Treasurer's Report: Nothing to report as J. Trainor is not in attendance.

Captain Vic is looking at fogging machines for sanitizing as it is simple and fast.

g. Race Management (see attached report):

Racing: -The RMC, also operating one day at a time, has pursued "Best Practices" via webinars and forums from US Sailing and YRA and our own brainstorming about racing and race management adjustments in the Covid-19 environment (planning, less RC personnel, eliminate flags and use horns only to reduce RC staff, dinghy starts, fixed marks, single and doublehanded or family racing, on-line RC and skipper meetings and award announcements, social distancing for racers and race committees...and more).

All Club races, and the August 30th Moonlight Open Regatta are staged and "in-the-ready" as if no pandemic. We are poised to respond with sailing instructions changes, cancellations, postponements, or date shuffling as needed. Already: -NSYC's May 30 Day Race Open Regatta was cancelled by us and with no postponement. -The Snyder Cup tied to the June 6 Club Cruise will likely be cancelled. -The Sunday, June 14, full crew Borden Cup Club Race will be swapped with the Singlehanded Epstein Cup race. -IC Regatta status is unknown -Start date for Thirsty Thursday racing has not been determined. -Sonar and MBOD one-design racing is cancelled for May.

L. Kulla notes that but under the circumstances it is not clear whether the sailing program will go forward.
